The Economic Community of West African States (ECOWAS Commission) has received financing from the World Bank toward the cost of the ***Regional Off-Grid Electricity Access Project (ROGEAP)*** and intends to apply part of the proceeds for consulting services.

The consulting services (“the Services”) include:

- Developing a manual/guide for the deployment of guarantee facilities by BOAD.
- Developing templates for contractual documents (e.g. guarantee agreement between BOAD and CFIs);
- Training of BOAD staff on the developed manual and contracting documents for the deployment of the facilities of Guarantee.
- Updating the Project Operation Manual (POM) by incorporating the developed implementation schemes and mechanisms for the guarantee facility.

The overall purpose is to assist the West African Development Bank (BOAD) in implementing CTF and CwA guarantee facility mechanisms in eligible countries in order to facilitate the use of the IDA credit line.

Qualification

- ✓ A master's degree in economics, finance, etc. or equivalent.

Experience and skills

- ✓ The consultant shall have at least:
 - 10 years of general professional experience in finance and at least 4 years in financial guarantees.
 - two experiences in supporting the implementation of financial guarantees.
 - two experiences in developing financial guarantee procedures.
 - one experience in capacity building.
 - knowledge of ROGEAP's areas of intervention.
 - Have a good command of French (spoken and written). Knowledge of English would be an asset.
- ✓ The Consultant must be proficient in IT tools, particularly Word and Excel.
- ✓ Knowledge of the energy sector, particularly off-grid photovoltaics, would be an asset.
